**High Risk Group Surveillance of Avian Influenza (Bird Flu)**

**Contact Follow Up Monitoring (Up to January , 2010) from IEDCR**

Avian Influenza Contact Follow Up Monitoring Committee regularly monitors the contact persons' follow up from the affected districts. The committee has started its activities from mid January 2008.

Contact Types: Persons involved in culling or Close Contact (less than 1 meter), Household Contact (more than 1 meter), Health Care Worker Contact (unprotected), Other Contacts (not household or not close).

Close Contacts are given Anti-Viral tablets as a single dose for 7 days and followed up for 14 days.

Other contacts are followed up for 14 days without any Anti-Viral tablets.

Follow Up is done daily by a Health Care Worker to detect 'Influenza Like Illness' (Fever, Cough and Respiratory Distress with H/O poultry contact.

If there is any suspected case, that is notified individually to IEDCR. Then necessary steps are taken accordingly.

From January 2010 to 8th February 2010, 5 out of 64 districts in Bangladesh were reported as affected by Bird Flu. 64 people were reported to be in contact with affected poultries within this period in 5 districts. Among them, 64 people were followed up for any suspected fever or Influenza Like Illness (ILI). Those who were in direct contact with poultries were given prophylactic anti-viral drug (Tab. Oseltamivir) daily for 7 days. All other contacts including the direct contacts were followed up for 14 days by an authorized health professional. 24 people completed 14 days follow up till to date. There was no report of any poultry outbreaks in February 2010.

Jaipurhat, Sirajganj, Lalmonirhat, Dhaka and Bogra districts were reported as Bird Flu affected districts up to January , 2010.

**Contact Follow Up Monitoring (January 2008 to December , 2009) from IEDCR**

Avian Influenza Contact Follow Up Monitoring Committee regularly monitors the contact persons' follow up from the affected districts. The committee has started its activities from mid January 2008.

Follow Up is done daily by a Health Care Worker to detect 'Influenza Like Illness' (Fever, Cough and Respiratory Distress with H/O poultry contact.

If there is any suspected case, that is notified individually to IEDCR. Then necessary steps are taken accordingly.

From January 2008 to 4th November 2009, 47 out of 64 districts in Bangladesh were reported as affected by Bird Flu. 4697 people were reported to be in contact with affected poultries within this period in 47 districts. Among them, 4184 people were followed up for any suspected fever or Influenza Like Illness (ILI). Those who were in direct contact with poultries were given prophylactic anti-viral drug (Tab. Oseltamivir) daily for 7 days. All other contacts including the direct contacts were followed up for 14 days by an authorized health professional. 3333 people completed 14 days follow up till to date. There was no report of any poultry outbreaks in June, July, August, October, November and December of 2008.

Comilla, Manikganj, Norshindi, Tangail, Gaibandha, Chittagong, Rajshai, Dinajpur, Rangpur, Netrokona and patuakhali districts were reported as Bird Flu affected districts up to November , 2009.

If there is any suspected case, that is notified individually to IEDCR. Then necessary steps are taken accordingly.

From January to 31st December 2008, 39 out of 64 districts in Bangladesh were reported as affected by Bird Flu. 4107 people were reported to be in contact with affected poultries within this period in 39 districts. Among them, 3788 people were followed up for any suspected fever or Influenza Like Illness (ILI). Those who were in direct contact with poultries were given prophylactic anti-viral drug (Tab. Oseltamivir) daily for 7 days. All other contacts including the direct contacts were followed up for 14 days by an authorized health professional. 2864 people completed 14 days follow up till to date. There was no report of any poultry outbreaks in June, July, August and October of 2008.
